4. Timely redressal of the grievances through appropriate committees

Timely and proper handling of grievances is essential for ensuring the satisfaction and quality of the campus experience for all stakeholders. In addition to the Grievance Redressal Cell, the institution has duly formed the Discipline Committee, Anti-Ragging Committee, SC/ST Cell, and Minority Monitoring Cell to resolve various categories of grievances. The committees working within this mechanism ensure effective solutions to grievances using a fair approach. The College Level Monitoring Committee (CLMC) takes all measures to ensure that the student grievances are promptly addressed. The CLMC addressed several other grievances effectively during the period.

- Requests for reappearance in internal tests were allowed, leading to subsequent mark improvement.
- Errors in registration for University examinations were rectified through direct correspondence with the Controller of Examinations, University of Kerala.
- Grievances regarding exam fee concessions were resolved in correspondence with the Controller of Examinations and University Computer Centre.
- Technical issues related to the University SLCM portal (including incorrect entries) were successfully resolved through correspondence with the Controller of Examinations and University Computer Centre.
